- ❖ All agreements will include green fee, cart, and range balls.
- ❖ Annual Passes are not valid for outside tournament play.
- ❖ 5 day passes are good Monday – Friday, not including any holidays observed by the United States.
- ❖ All pass holders are encouraged to make tee times.
- ❖ All Annual pass agreements are valid March 1, 2018 through February 28, 2019.
- ❖ Individuals age fifty-five (55) and over upon date of enrollment may apply for a Senior Pass.
- ❖ Family Passes shall include a couple and children under the age of twenty-one (21) living in the immediate household.
- ❖ Children age 13 and under play free with a paid green fee (pass holder or daily fee).
- ❖ Tabs will only be allowed for pass holders who have a credit card on file. If the pass holder leaves without paying the tab, the credit card will be run for the amount due.
- ❖ We are able to use the card on file to pay for any golf rounds not covered in the pass holder agreement, merchandise fees, or food and beverage fees at the golfer's will.
- ❖ Any pass holder who cancels his/her membership must provide a written, 30-day notice. The deposit will be forfeited.
- ❖ No personal checks for daily transactions.
- ❖ Individuals on the monthly payment plan will be charged on the 15th of each month. If the 15th falls on a Saturday, the charge will be made the Friday prior, if it falls on a Sunday, the charge will be made on Monday.
- ❖ Individuals on the monthly payment plan will be charged as shown in the example following: Example: Monthly 7-day family membership
 - March – \$380 deposit plus \$190 monthly fee
 - April – \$190 monthly fee
 - May - \$190 monthly fee
 - June - \$190 monthly fee
 - July - \$190 monthly fee
 - August - \$190 monthly fee
 - September - \$190 monthly fee
 - October - \$190 monthly fee
 - November - \$190 monthly fee
 - December - \$190 monthly fee
 - January – Deposit will be applied
 - February – Deposit will be applied
